All SSOP Patrollers shall ensure the following guidelines is adhered to regarding the proper use and care of SSOP issued radios.

1. General Rules of Radio Use

1.1 Device Care:

- I agree to take full responsibility for the care and maintenance of the SSOP-issued radio.
- I will ensure the device remains in good working condition and report any damage or malfunctions to the Patrol Captain immediately.

1.2 Device Ownership:

- The radio remains the **sole property of SSOP Patrollers** and will never become the property of the patroller.
- The patroller is renting the radio from SSOP Patrollers for the agreed fee of **R280.00 per month**.
- This fee must be paid **every month by no later than the 1st day of each month**. Failure to pay on time will result in the suspension of radio privileges.
- Upon suspension, expulsion, or termination of membership, the device must be **immediately returned** to the Patrol Captain in its original condition.

1.3 Restricted Use:

- The radio may never be given to or used by another party, whether they are a member of SSOP or not.
- Unauthorized individuals are strictly prohibited from accessing or using the device.

1.4 Language Policy:

- Only **English** is permitted for communication over the radio network to ensure clarity and uniform understanding among all members.

- Incident reports must align with radio communication for accurate documentation.
